### ACCORDING TO THE TYPE OF SALE

- Québec auctions — REGULAR, SPECIALIZED, SUPERVIZED SALES
- Recognized auctions outside Québec
- Provincial slaughterhouses — SALE OR CUSTOM
- Federal slaughterhouses — SLAUGHTER
- Local slaughterhouses — SALE ONLY (Type B)
- Cattle-insured producers (FADQ)
- Sale to a broker — QUÉBEC AUCTIONS, QUÉBEC SLAUGHTERHOUSES, CATTLE INSURED (FADQ), RECOGNIZED AUCTIONS OUTSIDE QUÉBEC
- Sale with **supervised weighing** — BROKERS OUTSIDE QUÉBEC, OTHER PRODUCERS

Eligible for ASRA based on the actual weight between 500 lb and 750 lb\*

- Sale to a broker
- Sale outside Québec
- Sale to another producer
- Unrecognized auction

**Without supervised weighing**

Eligible for ASRA based on an estimated weight of 500 lb\*

- Direct sale to a consumer on a live animal basis
- Consumption on the farm
- Custom slaughter at a local slaughterhouse (Type B)

**Not eligible under ASRA**

\* Providing the buyer transmits the information to the ATQ

### ACCORDING TO THE TYPE AND PLACE OF SLAUGHTER

#### SALE TO A SLAUGHTERHOUSE

- Provincial slaughterhouses (Type A)

- Local slaughterhouses (Type B)
- Slaughterhouses outside Québec recognized by FADQ

**INSURED FOR COW CALVES ONLY**

- ATQ producer number
- FADQ client number
- Tag number
- Site number of the operation
- Site number of origin
- Entry date



**INSURED FOR COW CALVES AND FEEDER CATTLE**

- FADQ client number
- Type of purchase
- Tag number
- Site number of the operation
- Site number of origin
- Sex
- Category (dairy or cattle)
- Purchase weight
- Invoice and weigh bill



**Animal Exits**

What to declare for **sales**

**INSURED FOR COW CALVES ONLY**  
for sales outside Québec or to a broker or producer

- ATQ producer number
- Tag number
- Site number of the operation
- Site number or place of destination
- Sales date



**INSURED FOR COW CALVES AND FEEDER CATTLE**

- FADQ client number
- Tag number
- Site number of the operation
- Site number or place of destination
- Sex
- Category (dairy or cattle)
- Type of exit
- Invoice and weigh bill



What to declare for **deaths**

**INSURED FOR COW CALVES AND/OR FEEDER CATTLE**

- ATQ producer number
- FADQ client number
- Tag number
- Site number of the operation
- Date of death
