B. PRODUCTIVE UNITS

In the framework of your participation in AgriStability, you must provide your operation's number of productive units for your fiscal period ending in 2011. Your productive units could be subject to an adjustment based on the period covered by your fiscal period, according to your 2011 declaration.

Notice to Participants

La Financière agricole du Québec (FADQ) commits to processing the information obtained to manage AgriStability, AgriInvest or Agri-Québec in strict confidentiality according to the provisions of the Act respecting Access to documents held by public bodies and the Protection of personal information (R.S.Q., c. A-2.1). The information may however be used in the framework of all FADQ programs or of any other programs it administers.

Moreover, as an AgriStability and AgriInvest administrator, La Financière agricole du Québec wishes to inform you that by registering in these programs, you consent to having the information communicated to Agriculture and Agri-Food Canada, for the purposes of audit, analysis, evaluation, program development and the issuing of payments relating to other programs.

Likewise, subject to a favourable ruling by the Commission d'accès à l'information, La Financière agricole du Québec is notifying you that it could, in the framework of an agreement with the Ministère de l'Agriculture, des Pêcheries et de l'Alimentation du Québec, exchange information needed in managing your file.

Furthermore, special terms apply if you participate in the Farm Income Stabilization Insurance program of Québec (ASRA). In accordance with that program, the amounts of the payments to which you are entitled, under your participation in AgriStability will be taken into account when calculating your stabilization insurance compensation. Consequently, any amount overpaid by ASRA will be deducted from these amounts.

In addition, in the framework of your participation in AgriStability, AgriInvest or Agri-Québec, you may be subject to an audit on a pre- or post-payment basis by La Financière agricole du Québec. Please also note that any information obtained, under your participation in these programs, could be communicated by La Financière agricole du Québec to the Canada Customs and Revenue Agency.

Finally, in accordance with the Parliament of Canada Act, no Member of the House of Commons shall be allowed to derive any financial advantage resulting from Canada's contributions under the AgriStability. Members of the Assemblée nationale du Québec and former federal public office holders and servants must comply with the conflict of interest guidelines in effect.

Program Participation

In order for farming operations to participate in the programs, the information found on this form must be transmitted to La Financière agricole. This document contains, among other things, the operation's identification number and authentication code assigned by La Financière agricole du Québec. If the farming operation chooses to transmit its financial information by an accredited financial information preparer, this information will grant that person access to the operation's file, making it possible for the preparer to process and transmit the information needed for participation in AgriStability, AgriInvest or Agri-Québec.

By participating in this program, the operation must:

- meet the eligibility conditions presented in the *Program Handbooks*;
- transmit, to La Financière agricole, its financial information for the 2011 year that was subject to an income (or loss) statement for tax purposes;
- ensure that the information provided in this document is accurate and complete;
- transmit, upon request, to La Financière agricole du Québec, any information needed to administer the program, notably tax information and proof to support the amounts of income and expenses reported in the financial statements;
- keep the participation support documents for a period of six years.
