- Transaction log in on-line file – AGI – AGQ
- 1st advance payment for 2018 and Final payment for 2017 – ASRA – Apples
- 2nd advance payment for 2018 – ASRA – Piglets, Hogs, Lambs

FEBRUARY

- 4 Launch – Contest *Tournez-vous vers l'excellence!*
- 22 Enrolment deadline – ASREC – Maple Syrup (deadline is February 15th, but extended until February 22nd)

APRIL

- 1 Enrolment deadline – ASREC – Apples Plan B
- 26 Registration deadline – Contest *Tournez-vous vers l'excellence!*
- 30 Enrolment deadline – ASREC – Cranberries, Cereals, Grain Corn, High-Protein Crops, Strawberries, Raspberries, Market Garden Crops (except Broccoli, Cauliflower and Gherkins for Processing), Honey, Potatoes – Collective: Cereals, Emerging Crops, Hay, Forage Corn, Grain Corn and Pastures
- 30 Enrolment deadline and deadline for paying contribution without any penalty – AGS
- 30 Enrolment deadline – ASRA – Cereals and Canola, Apples
 - Possibility of enrolment at any time: All other ASRA products
 - 2nd advance payment for 2018 – ASRA – Canola, Cereals
 - Final payment for 2018 – ASRA – Steers, Piglets, Hogs, Cow Calves and Grain-Fed Calves

MAY

- 15 Deadline for transmission to the MELCC – Phosphorus report
 - 2nd advance payment for 2018 – ASRA – Apples
 - Final payment for 2018 – ASRA – Lambs

JUNE

- 1 Deadline for reporting crops for 2018 – ASREC – Strawberries, Raspberries, Market Garden Crops (certain crops), Vegetables for Processing, Honey, Apples, Potatoes, Maple Syrup
- 24 Enrolment deadline – ASREC – Vegetables for Processing (Sweet Corn and Green Peas)

JULY

- 15 Enrolment deadline – ASREC – Vegetables for Processing (Fresh Beans)
 - 1st advance payment for 2019 – ASRA – Lambs, Steers, Piglets, Hogs, Cow Calves, Grain-Fed Calves

AUGUST

- 1 Deadline for reporting crops for 2018 – ASREC – Blueberries
- 15 Deadline for requesting winter coverage – ASREC – Haskap Berries (first year of planting)

SEPTEMBER

- 1 Deadline for requesting winter coverage – ASREC – Bees
- 1 Deadline for reporting seeded areas – ASREC – ASRA
- 15 Deadline for requesting winter coverage – ASREC – Strawberries

OCTOBER

- 1 Enrolment deadline – ASREC – Haskap Berries
- 1 Deadline for reporting crops for 2018 – ASREC – Cranberries, Cereals, Grain Corn, High-Protein Crops and Emerging Crops

NOVEMBER

- 1 Enrolment deadline – ASREC – Bees, Asparagus, Rhubarb
- 15 Enrolment deadline – ASREC – Strawberries, Raspberries
 - Award ceremony – Contest *Tournez-vous vers l'excellence!*

DECEMBER

- 1 Enrolment deadline – ASREC – Blueberries, Apple Trees-Plan A
- 31 Deadline for paying contribution with a penalty – AGS
 - Final collective settlement – ASREC – Cereals, Emerging Crops, Hay, Forage Corn, Grain Corn and Pastures
 - Final payment for 2018 and 1st advance payment for 2019 – ASRA – Canola, Cereals
 - 2nd advance payment for 2019 – ASRA – Steers, Cow Calves, Grain-Fed Calves

Transmission of financial information for AGRI: 9 months following the fiscal period end date without any penalty or 12 months at the most following the fiscal period end date with a penalty
