This guide provides additional explanations to help you complete the form correctly. Any individual or member of a group applying to La Financière agricole du Québec must complete an individual registration form, unless otherwise specified by La Financière agricole du Québec.

If this form is completed by hand, you must print in ink.

This form must be completed in its entirety.

1. Personal information If you are the subject of legal proceedings: ➤ Enter the date the legal proceedings began, the amount in question, and the reason for the proceedings.
2. Participation in one or more other businesses If you own shares, units, or interests in businesses other than the one in this application: ➤ Enter the exact legal name of these businesses.
3. Personal assets (excluding farm or forestry assets) Enter the value of personal assets and describe them briefly Other investments: ➤ Enter the value of securities held, such as term investments, stocks, bonds, etc. Vehicle: ➤ Enter the value of property such as trucks, cars, all-terrain vehicles, etc. Other assets: ➤ Enter the value of holdings, real estate such as income properties, businesses, cottages, land, etc.
4. Personal debts Enter any debts you have in your own name.
5. Other liabilities Enter all other liabilities you have as an individual (rent, lease, property taxes, alimony, electricity, etc.).
