



# COW-CALVES Checklist for Making Your Declarations

#### Who do I call?

#### For DECLARATIONS, QUESTIONS or CORRECTIONS

- Declaring entry on a shared site or a site that you do not own
- Missing or anomalous data regarding Agri-Traçabilité Québec (ATQ)
- Updating your inventory when abandoning or stopping production
- Changing ownership via testimony on the same rearing site (sale without moving)

#### Insured for cow calves only:

- Declaration of birth (activation)
- Declaration of entry and exit
- · Declaration of mortality
- · Replacing a tag
- Making a correction: site no., sex, date of birth

La Financière agricole Québec

- Insurability under the Farm Income Stabilization Program (ASRA)
- Calculating the number of breeding females
- · Calculating the kgs of calves sold
- Calculating the number of cow-calves sold
- Transferring coverage
- Closing a file (abandoning or stopping production)
- · Reasons for inadmissibility under the FADQ
- · Insurable volume and payments to ASRA

#### Insured for cow calves and steers:

- Declaration of birth (activation)
- · Declaration of entry and exit
- Declaration of mortality
- · Replacing a tag
- · Making a correction: site no., sex

#### For animals missing from the FADQ's production report

- Make sure that you made all your declarations to the ATQ before contacting your La Financière agricole advisor.
- Be sure to have your ATQ inventory in hand.
- Note that your production report is available in your client file on our website.

# Which weights will be used by the FADQ?

# For animals insurable under ASRA

(keep proof of the animals' marketing)

#### Recognized stakeholders - Actual weight

- Recognized auction barns in and outside of Quebec
- Slaughterhouses<sup>\*</sup>:
  - o federal
  - provincial
  - o local
- Recognized slaughterhouses outside of Quebec
- Producer insured for the Steer product and slaughter cattle under ASRA (if the producers respects the terms of the program)
- Weigh-in officers (supervised weighing services offered by Quebec auction barns, as well as the Centre de développement du porc du Québec)
- Centre de développement du porc du Québec for animals evaluated and sold after genetic testing (testing station and genetic evaluation program – supervised version)

The actual weight is also used when a sale to a seller is followed by an entry declared by one of his/her buyers when the events take place within the seven calendar-day period processed by the FADQ.

# Non-recognized stakeholders – Estimated weight (limited to 450 lbs)

- Seller or another cow-calf producer
- Bound for outside of Quebec (unknown buyer, with no entry declaration on his/her site at ATQ)
- Slaughterhouses or auction barns in Quebec or outside of Quebec if not recognized for weight

\*Custom slaughtering by federal and provincial slaughterhouses – the client must hold a retail license permitting the meat to be sold to consumers

#### What animals are not insurable under ASRA?

- Custom slaughtering by a local slaughterhouse
- · Direct sale of live animals to a consumer
- Personal consumption
- Condemned animals
- Animals weighing less than 450 lbs at sale
- Animals with no date of birth

# What to declare and to whom?

#### At ALL TIMES to the ATQ OR FADQ, DEPENDING ON THE CASE

Within 7 days of affixing the tags or of the event if INSURED FOR COW-CALVES ONLY

Within 45 days of the event or when the animal reaches 700 lbs if INSURED FOR COW-CALVES and STEERS. The FADQ transmits this information to the ATQ for the clients concerned.



#### VITAL information required for each event declared:

- FADQ client number
- ATQ producer number (if the declaration is being made to the ATQ)
- Tag number
- Operating site number (declaration site)
- · Cow-calf production (VEE) for declarations to the ATQ

#### **BIRTHS**

## INSURED FOR COW-CALVES ONLY (ATQ)

- WITAL information
- Sex
- · Actual date of birth
- Category (dairy or beef)

#### INSURED FOR COW-CALVES AND STEERS (FADQ)\*

- **VITAL** information
- Sex
- · Actual date of birth
- Category (dairy or beef)
- · Weight at birth

The tags must be affixed within seven days of birth (or within 5 months if the calf born is on pasture) or before exiting the operation, whichever comes first.

#### **ANIMALS PURCHASED and MOVED**

#### INSURED FOR COW-CALVES ONLY (ATQ)

- WITAL information
- · Site number or place of origin
- Date of entry on your site for every animal purchase or every move in Quebec or outside of Quebec
- Date of entry or change of ownership on the site on which you raise the animals
- Date of entry for all moves to a shared site or a site that you do not own
- Sex and data of birth for purchases made outside of Quebec

#### **INSURED FOR COW-CALVES AND STEERS**

#### PURCHASES (FADQ)\*

- WITAL information
- Type of purchase
- Site number or place of origin
- · Animal purchase date
- Sex
- Category (dairy or beef)
- · Weight at purchase
- Invoice and weight slip

#### ANIMALS MOVED (ATQ)

- WITAL information
- Current site number (entry) and animal's place of origin
- Date of entry on your site for each move in Quebec or outside of Quebec
- Date of entry of all moves to a shared site or a site that you do not own

# INSURED FOR COW-CALVES ONLY (ATQ)

- VITAL information
- Date of sale or exit
- Destination site number or destination

#### INSURED FOR COW-CALVES AND STEERS (FADQ)\*

- WITAL information
- · Sex and date of sale
- Destination site number or destination
- Category (dairy or beef)
- Type of exit
- Invoice and weight slip

#### **Animals DYING**

#### INSURED FOR COW-CALVES (ATQ)

- VITAL information
- Date of death

#### INSURED FOR COW-CALVES AND STEERS (ATQ and FADQ)\*

- VITAL information
- Date of death
