

## Farm income stabilization insurance Program Product Cow Calves Production statement checklist

The table below gives the reasons why an offspring (identifier number) is ineligible for your insurable volume and a female is not considered as part of your breeding herd in your insurance file. Please note that you are always responsible for ensuring the conformity of the information in your file at Agri-Traçabilité Québec (ATQ) and at La Financière agricole du Québec (FADQ). If you notice any errors regarding your event declarations, please contact the ATQ. However, for information involving your insurable volume, contact your FADQ insurance representative. Any request for a correction must be justified and supported by documentary proof.

Reason and description	Contact FADQ
<p><b>Compliant transitory or local slaughterhouse</b></p> <p>The animal is slaughtered in a compliant transitory or local slaughterhouse (formerly Type B). The regulation requires that the animal be sold to the slaughterhouse.</p> <p>The list of slaughterhouses with a permit is available on the FADQ's website at <a href="http://www.fadq.qc.ca">www.fadq.qc.ca</a> and a link is given for the MAPAQ's website.</p>	<p>Provide your service centre insurance representative with documentary proof of the animal: sales invoice, proof of money received (cash receipts, copies of cheques stamped by the financial institution) or any other documentary proof.</p>
<p><b>Error in a transaction when a contract is transferred</b></p> <p>When an insurance contract is transferred, all animals registered in the seller's ATQ file are transferred to the purchaser's file at ATQ. For an animal included in an insurance contract transfer, there is an error in the entry or exit information.</p>	
<p><b>Stakeholder not recognized – Type of stakeholder unknown at FADQ</b></p> <p>According to information held by FADQ, a stakeholder is unknown when information on the animal comes from a stakeholder that does not deal in animals. For example:</p> <ul style="list-style-type: none"> <li>• ATQ</li> <li>• A stakeholder not listed at the FADQ</li> </ul> <p>The type of stakeholder has never sent any information to the ATQ before.</p>	<p>Inform your service centre insurance representative so this can be verified.</p>
<p><b>Ownership not recognized</b></p> <p>The animal was sold but the FADQ cannot match the animal's ownership to the seller since the FADQ client number is missing, or the animal's site of origin, if reported by the buyer, does not belong to the seller client. The animal's exit declaration is missing.</p>	
<p><b>Animal made ineligible by the service centre</b></p> <p>An analysis of information on the animal showed that it is not eligible or cannot be considered as part of the breeding herd.</p>	
<p><b>Exit inside Québec without sales information – Exit outside Québec without sales information</b></p> <p>An animal left the farm, but no purchase was declared to the ATQ. Whether or not the exit is in Québec or outside Québec, the transaction is considered as being without sales information and must be accepted by FADQ, if necessary.</p>	<p>Provide your service centre insurance representative the sales receipt, the weighing proof, documents regarding the birth of the animal or any other documentary proof when corrections are required.</p>

Reason and description (continued)	Contact FADQ
<p><b>Exit of animal was not declared</b></p> <p>According to the program or traceability regulations, the animal's exit must be reported by the participant.</p>	<p>Provide your service centre insurance representative with the sales receipt, proof of weighing, documents regarding the animal's birth or any other document to proof corrections are required.</p>
<p><b>Exit followed by a death – Sale followed by a death</b></p> <p>FADQ received a date of death for the animal, but this death is missing from the exit or sales events processed by FADQ to evaluate the seller's insurable volume. To be eligible for ASRA, the sale of animal must be justified.</p>	
<p><b>Slaughterhouse's conversion rate missing</b></p> <p>The slaughterhouse did not provide information about the weighing method used at the time of slaughter</p>	

Reason and description	Contact FADQ or ATQ
<p><b>Animal insured in another FADQ product</b></p> <p>The animal is already insured, either in the product "Feeder Cattle and Slaughter Cattle," or the product "Milk-Fed Calves," and cannot benefit from compensation for the product "Cow Calves."</p>	<p>Make sure the electronic chip number of the animal in your herd corresponds to the number in your ATQ file. If so, contact FADQ to provide documentary proof.</p> <p>Contact ATQ to update your file if the electronic chip number does not correspond to the one in your file.</p>
<p><b>Dead animal, according to another FADQ product</b></p> <p>The animal is dead, according to information given for the products "Feeder Cattle and Slaughter Cattle" or "Milk-Fed Calves." Consequently, it cannot benefit from compensation for the product "Cow Calves."</p>	

Reason and description	Contact ATQ
<p><b>Entry date to be confirmed</b></p> <p>Purchases of female breeders were not reported at the time of purchase.</p>	<p>Report all animal movements, in particular entries and exits, and specify the event's actual date.</p>
<p><b>Identifier missing at least one piece of information</b></p> <p>One or more date for identifier is incomplete or missing for the identifier. The missing data will be listed in the statement.</p>	<p>Provide information concerning the identifier, including all information relating to the birth of animals when you are the owner.</p>
<p><b>Identifier for more than one producer at a same site</b></p> <p>When an identifier is associated with a site belonging to several producers and the ownership is not clearly established, the identifier is associated with all owners associated with the site.</p>	<p>Provide your FADQ client number so it can be associated with the animal's identifier number when you are the animal's owner.</p>
<p><b>Identifier for more than one producer on different sites</b></p> <p>An identifier is associated with more than one producer and they are not at the same site.</p>	
<p><b>Identifier with incoherent data</b></p> <p>One or more data is incoherent with the animal's life chronology or the events registered for the identifier. For example, the date of sale is later than the date of death. This data is provided on the statement.</p>	<p>Provide additional information to regularize the identifier when information given for an event contains errors.</p>

Reason and description(continued)	Contact ATQ
<p><b>Replacement of a tag or unknown PI</b></p> <p>The permanent identification (PI) number replaces another PI without any match to the number of the original tag enabled has been replaced.</p>	<p>Provide the new tag number that replaces the original tag number. The tag number or the tag to be replaced must be retraced and reported.</p>

For the following situations, you have nothing to do. However, for more information on terms and conditions, the program's administrative standards or stakeholders reporting information, please contact your FADQ insurance representative. You are responsible for meeting regulatory obligations.

Reason and description
<p><b>Slaughterhouse closed – Slaughterhouse does not comply – Slaughterhouse not recognized by FADQ – Slaughter without slaughterhouse</b></p> <p>According to information held by the FADQ, the slaughterhouse is closed and had no slaughter permit at the time the animal was slaughtered. FADQ checks the compliance of federal, provincial or local slaughterhouses (or transitory) with the MAPAQ or Canadian Food Inspection Agency (CFIAIA). Animals slaughtered in a slaughterhouse not recognized by the FADQ for data transmission are not eligible: those slaughtered at a site that is not that of a slaughterhouse or the declarant is not a slaughterhouse.</p> <p>The list of slaughterhouses with permits is available on FADQ's website at <a href="http://www.fadq.gc.ca">www.fadq.gc.ca</a>, and a link are given to the MAPAQ and the CFIA websites.</p>
<p><b>Calf over maximum age</b></p> <p>The age of the calf sold for breeding is over the maximum age allowed (max. of 30 months).</p>
<p><b>Animal already sold</b></p> <p>The calf was not born on your farm in Québec. It was therefore already sold a first time and is not eligible.</p>
<p><b>Calves whose entire carcass is condemned</b></p> <p>ATQ sent FADQ information indicating that the animal's carcass was condemned at the time of slaughter.</p>
<p><b>Dead animal</b></p> <p>The calf is dead according to information received: information from the rendering plant, laboratory (necropsy) or death certificate.</p>
<p><b>Animal taken outside Québec</b></p> <p>The animal was taken outside Québec at one time or another during finishing without having been sold.</p>
<p><b>Offspring not eligible</b></p> <p>Offspring belonging to a cattle financing cooperative are not eligible.</p>
<p><b>Time owned under required minimum</b></p> <p>Only females owned for a minimum of six consecutive months prior to a transaction (sale) are considered as part of the female breeder herd.</p>
<p><b>Birth outside Québec</b></p> <p>Calves must be born on a farm in Québec.</p>
<p><b>Birth does not comply</b></p> <p>Only births declared by producer-breeders or certain authorized agents are eligible.</p>
<p><b>Weight below minimum</b></p> <p>The weight of the calf sold is below the minimum of 500 lb (226,8 kg) required until December 31, 2011 or 450 lb (204,1 kg) since January 1, 2012.</p>

## Reason and description (continued)

### **Sold offspring returned as a breeder**

A calf born on a farm in Québec is sold, but is repurchased and returned to the inventory as a female breeder for the same client that saw it born.

### **Transfer of the seller's contract**

Since you have sold your insurance contract, insured animals were transferred to the purchaser of your herd insured by FADQ.

### **Sale after file is closed**

A calf was sold after the insurance (ASRA) file was closed.

### **Sale to a consumer**

The animal was sold to a consumer and therefore is not insurable.
